

1 AN ACT relating to child welfare.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 6 IS CREATED TO
4 READ AS FOLLOWS:

- 5 *(1) The Child Welfare Oversight and Advisory Committee of the Kentucky General*
6 *Assembly is hereby established. The purpose of the committee shall be to review,*
7 *analyze, and provide oversight to the General Assembly on child welfare within*
8 *the Commonwealth related but not limited to foster care, adoption, and child*
9 *abuse, neglect, and dependency.*
- 10 *(2) The Child Welfare Oversight and Advisory Committee shall consist of ten (10)*
11 *members appointed as follows: three (3) members of the Senate appointed by the*
12 *President of the Senate; two (2) members of the minority party in the Senate*
13 *appointed by the Minority Floor Leader in the Senate; three (3) members of the*
14 *House of Representatives appointed by the Speaker of the House of*
15 *Representatives; and two (2) members of the minority party in the House of*
16 *Representatives appointed by the Minority Floor Leader in the House of*
17 *Representatives. Members appointed from each chamber shall elect one (1)*
18 *member from their chamber to serve as co-chair.*
- 19 *(3) The co-chairs of the Child Welfare Oversight and Advisory Committee shall have*
20 *joint responsibilities for committee meeting agendas and presiding at committee*
21 *meetings. The committee shall meet at least two (2) times annually.*
- 22 *(4) A majority of the entire membership of the Child Welfare Oversight and Advisory*
23 *Committee shall constitute a quorum, and all actions of the committee shall be by*
24 *vote of a majority of its entire membership.*
- 25 *(5) The Legislative Research Commission shall have exclusive jurisdiction over the*
26 *employment of personnel necessary to carry out the provisions of this section.*
27 *Staff and operating costs of the Child Welfare Oversight and Advisory Committee*

1 *shall be provided from the budget of the Legislative Research Commission.*

2 ➔Section 2. KRS 194A.030 is amended to read as follows:

3 The cabinet consists of the following major organizational units, which are hereby
4 created:

5 (1) Office of the Secretary. Within the Office of the Secretary, there shall be an Office
6 of Communications and Administrative Review, an Office of Legal Services, an
7 Office of Inspector General, an Office of the Ombudsman, and the Governor's
8 Office of Electronic Health Information.

9 (a) The Office of Communications and Administrative Review shall include
10 oversight of administrative hearings and communications with internal and
11 external audiences of the cabinet. The Office of Communications and
12 Administrative Review shall be headed by an executive director who shall be
13 appointed by the secretary with the approval of the Governor under KRS
14 12.050.

15 (b) The Office of Legal Services shall provide legal advice and assistance to all
16 units of the cabinet in any legal action in which it may be involved. The Office
17 of Legal Services shall employ all attorneys of the cabinet who serve the
18 cabinet in the capacity of attorney, giving legal advice and opinions
19 concerning the operation of all programs in the cabinet. The Office of Legal
20 Services shall be headed by a general counsel who shall be appointed by the
21 secretary with the approval of the Governor under KRS 12.050 and 12.210.
22 The general counsel shall be the chief legal advisor to the secretary and shall
23 be directly responsible to the secretary. The Attorney General, on the request
24 of the secretary, may designate the general counsel as an assistant attorney
25 general under the provisions of KRS 15.105.

26 (c) The Office of Inspector General shall be responsible for:

27 1. The conduct of audits and investigations for detecting the perpetration of

1 fraud or abuse of any program by any client, or by any vendor of
 2 services with whom the cabinet has contracted; and the conduct of
 3 special investigations requested by the secretary, commissioners, or
 4 office heads of the cabinet into matters related to the cabinet or its
 5 programs;

- 6 2. Licensing and regulatory functions as the secretary may delegate;
- 7 3. Review of health facilities participating in transplant programs, as
 8 determined by the secretary, for the purpose of determining any
 9 violations of KRS 311.1911 to 311.1959, 311.1961, and 311.1963; and
- 10 4. The notification and forwarding of any information relevant to possible
 11 criminal violations to the appropriate prosecuting authority.

12 The Office of Inspector General shall be headed by an inspector general who
 13 shall be appointed by the secretary with the approval of the Governor. The
 14 inspector general shall be directly responsible to the secretary.

15 (d) ~~{The Office of the Ombudsman shall provide professional support in the~~
 16 ~~evaluation of programs, including but not limited to quality improvement and~~
 17 ~~information analysis and reporting, contract monitoring, program monitoring,~~
 18 ~~and the development of quality service delivery, and a review and resolution~~
 19 ~~of citizen complaints about programs or services of the cabinet when those~~
 20 ~~complaints are unable to be resolved through normal administrative remedies.~~
 21 ~~The Office of the Ombudsman shall place an emphasis on research and best~~
 22 ~~practice and program accountability and shall monitor federal compliance.~~
 23 ~~The Office of the Ombudsman shall be headed by an executive director who~~
 24 ~~shall be appointed by the secretary with the approval of the Governor in~~
 25 ~~accordance with KRS 12.050.~~

26 (e) ~~—~~ The Governor's Office of Electronic Health Information shall provide
 27 leadership in the redesign of the health care delivery system using electronic

1 information technology as a means to improve patient care and reduce medical
2 errors and duplicative services. The Governor's Office of Electronic Health
3 Information shall be headed by an executive director who shall be appointed
4 by the secretary with the approval of the Governor in accordance with KRS
5 12.050;

6 (2) Department for Medicaid Services. The Department for Medicaid Services shall
7 serve as the single state agency in the Commonwealth to administer Title XIX of the
8 Federal Social Security Act. The Department for Medicaid Services shall be headed
9 by a commissioner for Medicaid services, who shall be appointed by the secretary
10 with the approval of the Governor under KRS 12.050. The commissioner for
11 Medicaid services shall be a person who by experience and training in
12 administration and management is qualified to perform the duties of this office. The
13 commissioner for Medicaid services shall exercise authority over the Department
14 for Medicaid Services under the direction of the secretary and shall only fulfill those
15 responsibilities as delegated by the secretary;

16 (3) Department for Public Health. The Department for Public Health shall develop and
17 operate all programs of the cabinet that provide health services and all programs for
18 assessing the health status of the population for the promotion of health and the
19 prevention of disease, injury, disability, and premature death. This shall include but
20 not be limited to oversight of the Division of Women's Health. The Department for
21 Public Health shall be headed by a commissioner for public health who shall be
22 appointed by the secretary with the approval of the Governor under KRS 12.050.
23 The commissioner for public health shall be a duly licensed physician who by
24 experience and training in administration and management is qualified to perform
25 the duties of this office. The commissioner shall advise the head of each major
26 organizational unit enumerated in this section on policies, plans, and programs
27 relating to all matters of public health, including any actions necessary to safeguard

1 the health of the citizens of the Commonwealth. The commissioner shall serve as
2 chief medical officer of the Commonwealth. The commissioner for public health
3 shall exercise authority over the Department for Public Health under the direction of
4 the secretary and shall only fulfill those responsibilities as delegated by the
5 secretary;

6 (4) Department for Behavioral Health, Developmental and Intellectual Disabilities. The
7 Department for Behavioral Health, Developmental and Intellectual Disabilities shall
8 develop and administer programs for the prevention of mental illness, intellectual
9 disabilities, brain injury, developmental disabilities, and substance abuse disorders
10 and shall develop and administer an array of services and support for the treatment,
11 habilitation, and rehabilitation of persons who have a mental illness or emotional
12 disability, or who have an intellectual disability, brain injury, developmental
13 disability, or a substance abuse disorder. The Department for Behavioral Health,
14 Developmental and Intellectual Disabilities shall be headed by a commissioner for
15 behavioral health, developmental and intellectual disabilities who shall be
16 appointed by the secretary with the approval of the Governor under KRS 12.050.
17 The commissioner for behavioral health, developmental and intellectual disabilities
18 shall be by training and experience in administration and management qualified to
19 perform the duties of the office. The commissioner for behavioral health,
20 developmental and intellectual disabilities shall exercise authority over the
21 department under the direction of the secretary, and shall only fulfill those
22 responsibilities as delegated by the secretary;

23 (5) Commission for Children with Special Health Care Needs. The duties,
24 responsibilities, and authority set out in KRS 200.460 to 200.490 shall be performed
25 by the commission. The commission shall advocate the rights of children with
26 disabilities and, to the extent that funds are available, shall ensure the
27 administration of services for children with disabilities as are deemed appropriate

1 by the commission pursuant to Title V of the Social Security Act. The commission
2 may promulgate administrative regulations under KRS Chapter 13A as may be
3 necessary to implement and administer its responsibilities. The duties,
4 responsibilities, and authority of the Commission for Children with Special Health
5 Care Needs shall be performed through the office of the executive director. The
6 executive director shall be appointed by the secretary with the approval of the
7 Governor under KRS 12.050;

8 (6) Office of Health Policy. The Office of Health Policy shall lead efforts to coordinate
9 health care policy, including Medicaid, behavioral health, developmental and
10 intellectual disabilities, mental health services, services for individuals with an
11 intellectual disability, public health, certificate of need, and health insurance. The
12 duties, responsibilities, and authority pertaining to the certificate of need functions
13 and the licensure appeal functions, as set out in KRS Chapter 216B, shall be
14 performed by this office. The Office of Health Policy shall be headed by an
15 executive director who shall be appointed by the secretary with the approval of the
16 Governor pursuant to KRS 12.050;

17 (7) Department for Family Resource Centers and Volunteer Services. The Department
18 for Family Resource Centers and Volunteer Services shall streamline the various
19 responsibilities associated with the human services programs for which the cabinet
20 is responsible. This shall include, but not be limited to, oversight of the Division of
21 Family Resource and Youth Services Centers and the Kentucky Commission on
22 Community Volunteerism and Services. The Department for Family Resource
23 Centers and Volunteer Services shall be headed by a commissioner who shall be
24 appointed by the secretary with the approval of the Governor under KRS 12.050.
25 The commissioner for family resource centers and volunteer services shall be by
26 training and experience in administration and management qualified to perform the
27 duties of the office, shall exercise authority over the department under the direction

1 of the secretary, and shall only fulfill those responsibilities as delegated by the
2 secretary;

3 (8) Office of Administrative and Technology Services. The Office of Administrative
4 and Technology Services shall develop and maintain technology, technology
5 infrastructure, and information management systems in support of all units of the
6 cabinet. The office shall have responsibility for properties and facilities owned,
7 maintained, or managed by the cabinet. The Office of Administrative and
8 Technology Services shall be headed by an executive director who shall be
9 appointed by the secretary with the approval of the Governor under KRS 12.050.
10 The executive director shall exercise authority over the Office of Administrative
11 and Technology Services under the direction of the secretary and shall only fulfill
12 those responsibilities as delegated by the secretary;

13 (9) Office of Human Resource Management. The Office of Human Resource
14 Management shall coordinate, oversee, and execute all personnel, training, and
15 management functions of the cabinet. The office shall focus on the oversight,
16 development, and implementation of quality personnel services; curriculum
17 development and delivery of instruction to staff; the administration, management,
18 and oversight of training operations; health, safety, and compliance training; and
19 equal employment opportunity compliance functions. The office shall be headed by
20 an executive director appointed by the secretary with the approval of the Governor
21 in accordance with KRS 12.050;

22 (10) The Office of Finance and Budget shall provide central review and oversight of
23 budget, contracts, and cabinet finances. The office shall provide coordination,
24 assistance, and support to program departments and independent review and
25 analysis on behalf of the secretary. The office shall be headed by an executive
26 director appointed by the secretary with the approval of the Governor in accordance
27 with KRS 12.050;

- 1 (11) Department for Community Based Services. The Department for Community Based
2 Services shall administer and be responsible for child and adult protection, violence
3 prevention resources, foster care and adoption, permanency, and services to enhance
4 family self-sufficiency, including child care, social services, public assistance, and
5 family support. The department shall be headed by a commissioner appointed by the
6 secretary with the approval of the Governor in accordance with KRS 12.050;
- 7 (12) Department for Income Support. The Department for Income Support shall be
8 responsible for child support enforcement and disability determination. The
9 department shall serve as the state unit as required by Title II and Title XVI of the
10 Social Security Act, and shall have responsibility for determining eligibility for
11 disability for those citizens of the Commonwealth who file applications for
12 disability with the Social Security Administration. The department shall be headed
13 by a commissioner appointed by the secretary with the approval of the Governor in
14 accordance with KRS 12.050;
- 15 (13) Department for Aging and Independent Living. The Department for Aging and
16 Independent Living shall serve as the state unit as designated by the Administration
17 on Aging Services under the Older Americans Act and shall have responsibility for
18 administration of the federal community support services, in-home services, meals,
19 family and caregiver support services, elder rights and legal assistance, senior
20 community services employment program, the state health insurance assistance
21 program, state home and community based services including home care,
22 Alzheimer's respite services and the personal care attendant program, certifications
23 of adult day care and assisted living facilities, the state Council on Alzheimer's
24 Disease and other related disorders, the Institute on Aging, and guardianship
25 services. The department shall also administer the Long-Term Care Ombudsman
26 Program and the Medicaid Home and Community Based Waivers Consumer
27 Directed Option (CDO) Program. The department shall serve as the information and

1 assistance center for aging and disability services and administer multiple federal
2 grants and other state initiatives. The department shall be headed by a commissioner
3 appointed by the secretary with the approval of the Governor in accordance with
4 KRS 12.050;~~and~~

5 (14) The Office of Legislative and Regulatory Affairs shall provide central review and
6 oversight of legislation, policy, and administrative regulations. The office shall
7 provide coordination, assistance, and support to program departments and
8 independent review and analysis on behalf of the secretary. The office shall be
9 headed by an executive director appointed by the secretary with the approval of the
10 Governor in accordance with KRS 12.050; and

11 (15) The Office of the Ombudsman shall investigate, upon complaint or on its own
12 initiative, any administrative act of an agency, employee, or contractor of the
13 cabinet, without regard to the finality of the administrative act. Agencies,
14 employees, or contractors shall not restrict access to records or personnel. The
15 Office of the Ombudsman shall make recommendations that resolve citizen
16 complaints and improve governmental performance, and may request corrective
17 action when policy violations are noted. The Office of the Ombudsman shall
18 provide evaluation and information analysis of cabinet performance and
19 compliance with state and federal policy. The Office of the Ombudsman shall
20 place an emphasis on research and best practices, program accountability,
21 quality service delivery, and improved governmental performance. The Office of
22 the Ombudsman shall ensure that information relating to how to contact the
23 office shall be publically posted at all facilities where agency employees or
24 contractors work, publically posted at any facility where a child in the custody of
25 the cabinet resides or is treated, and given to all cabinet or contracted foster
26 parents. The Office of the Ombudsman shall report to the Office of Inspector
27 General any charge or case against an employee of the Cabinet for Health and

1 *Family Services where it has cause to believe the employee has engaged in*
 2 *dishonest, unethical, or illegal conduct or practices related to his or her job*
 3 *duties. The Office of the Ombudsman shall compile a report of all citizen*
 4 *complaints about programs or services of the cabinet and a summary of*
 5 *resolution of the complaints and shall submit the report by December 1 of each*
 6 *year to the Child Welfare Oversight and Advisory Committee established in*
 7 *Section 1 of this Act. The Office of the Ombudsman shall be headed by an*
 8 *executive director who shall be appointed by the secretary with the approval of*
 9 *the Governor in accordance with KRS 12.050.*

10 ➔Section 3. KRS 199.461 is amended to read as follows:

- 11 (1) As used in this section, "social service worker" means a social worker employed by
 12 the Cabinet for Health and Family Services, Department for Community Based
 13 Services, to provide direct casework services in foster care, child protection,
 14 juvenile services, or adult protection.
- 15 (2) As used in this section, "active case" includes the total number of cases for which
 16 the family service worker has responsibility.
- 17 (3) The monthly statewide caseload average for social service workers in the area of
 18 foster care, child protection, juvenile services, or adult protection shall not exceed
 19 twenty-five (25) active cases.
- 20 (4) Nothing in this section shall prevent the department or a social service worker from
 21 handling emergencies to carry out statutory mandates. If the monthly *regional,*
 22 *county, or* statewide caseload average for social service workers exceeds twenty-
 23 five (25) active cases for ninety (90) consecutive days, the department shall report
 24 the fact to the Governor and to the Legislative Research Commission together with
 25 a description of the factors contributing thereto and shall make recommendations
 26 related thereto. The report shall include, by county and *region*~~[district]~~, social
 27 service worker caseload averages; the number of established social service worker

1 positions; and the number of vacant social service worker positions.

2 ➔Section 4. KRS 199.470 is amended to read as follows:

- 3 (1) Any person who is eighteen (18) years of age and who is a resident of this state or
4 who has resided in this state for twelve (12) months next before filing may file a
5 petition for leave to adopt a child in the Circuit Court of the county in which the
6 petitioner resides.
- 7 (2) If the petitioner is married, the husband or wife shall join in a petition for leave to
8 adopt a child unless the petitioner is married to a biological parent of the child to be
9 adopted, except that if the court finds the requirement of a joint petition would serve
10 to deny the child a suitable home, the requirement may be waived.
- 11 (3) If a child is placed for adoption by the cabinet, by an agency licensed by the cabinet,
12 or with written approval by the secretary of the cabinet, the petition may be filed at
13 the time of placement. In all other adoptions, the petition shall not be filed until the
14 child has resided continuously in the home of the petitioner for at least ninety (90)
15 days immediately prior to the filing of the adoption petition.
- 16 (4) No petition for adoption shall be filed unless prior to the filing of the petition the
17 child sought to be adopted has been placed for adoption by a child-placing
18 institution or agency, or by the cabinet, or the child has been placed with written
19 approval of the secretary; but no approval shall be necessary in the case of:
- 20 (a) A child sought to be adopted by a **blood relative, including a relative of half-**
21 **blood, first cousin, aunt, uncle, nephew, niece, and a person of a preceding**
22 **generation as denoted by prefixes of grand, great, or great-great;**
23 **stepparent; step-sibling; or fictive kin**~~[stepparent, grandparent, sister, brother,~~
24 ~~aunt, uncle, great-grandparent, great-aunt, or great-uncle];~~ however, the court
25 in its discretion may order a report in accordance with KRS 199.510 and a
26 background check as provided in KRS 199.473(8);
- 27 (b) A child received by the proposed adopting parent or parents from an agency

1 without this state with the written consent of the secretary; ~~{or}~~

2 (c) A child adopted under the provisions of KRS 199.585(1); or

3 (d) A child who has been approved under KRS Chapter 615.

4 ~~{(5) Subsection (4) of this section shall not apply to children placed for adoption prior to~~
5 ~~June 14, 1962.}~~

6 ➔Section 5. KRS 199.641 is amended to read as follows:

7 (1) As used in this section, unless the context otherwise requires:

8 (a) "Allowable costs report" means a report from each child-caring facility or
9 child-placing agency that contracts with the department for services and
10 includes all allowable costs as defined by the Federal Office of Management
11 and Budget's guidance, including Title 2 of the Code of Federal
12 Regulations~~{Budget circular A 122, "cost principles for nonprofit~~
13 ~~organizations,"}~~ and other information the department may require, utilizing
14 cost data from each child-caring facility's or child-placing agency's most
15 recent yearly audited financial statement;

16 (b) ~~{"Child-caring facility" means any institution or group home other than a state~~
17 ~~facility, or one certified by an appropriate agency as operated primarily for~~
18 ~~educational or medical purposes providing residential care on a twenty-four~~
19 ~~(24) hour basis to children, not related by blood, adoption, or marriage to the~~
20 ~~person maintaining the facility;~~

21 (e) ~~}"Department" means the Department for Community Based Services of the~~
22 ~~Cabinet for Health and Family Services;~~

23 (c){(d)} "Model program cost analysis" means a report based on a time study, the
24 allowable costs report, and other information required by the department from
25 each child-caring facility or child-placing agency that contracts with the
26 department for services that determines a statewide median cost for each
27 licensed program category of service provided by child-caring facilities or

1 *child-placing agencies*; and

2 ~~(d)~~~~(e)}~~ "Time study" means the process of reporting the work performed by
3 employees of child-caring facilities *or child-placing agencies* in specified
4 time periods.

5 (2) Subject to the limitations set forth in subsection (4) of this section, when the
6 department chooses to contract with a ~~nonprofit~~ child-caring facility *or child-*
7 *placing agency* for services to a child *in the custody of or* committed to the
8 department, the department shall make payments to that facility based on the rate
9 setting methodology developed from the model program cost analysis. The
10 department shall also assure that the methodology:

11 (a) Provides payment incentives for moving children as quickly as possible to a
12 permanent, continuous, stable environment;

13 (b) Provides children who require out-of-home care or alternative treatment with
14 placements that are as close as possible to their home geographic area *and*
15 *ensure continuity with their families, schools, faiths, and communities*;
16 ~~and~~

17 (c) Provides appropriate placement and treatment services that effectively and
18 efficiently meet the needs of the child and the child's family as close as
19 possible to the child's home geographic area; *and*

20 *(d) Facilitates provider participation in the State Medicaid Program established*
21 *in accordance with KRS Chapter 205.*

22 (3) The department shall use the model program cost analysis as a basis for cost
23 estimates for the development of the department's biennial budget request.

24 (4) The secretary shall, to the extent funds are appropriated, establish and implement
25 the rate setting methodology and rate of payment by promulgation of administrative
26 regulations in accordance with KRS Chapter 13A that are consistent with the level
27 and quality of service provided by child-caring facilities. The administrative

1 regulations shall also include the forms and formats for the model program cost
2 analysis.

3 **(5) Nothing in this section shall prohibit the department from soliciting proposals to**
4 **improve or expand alternative services for children in the custody of or**
5 **committed to the cabinet.**

6 ➔Section 6. KRS 199.800 is amended to read as follows:

7 For the purposes of KRS 199.800 to **199.801**~~[199.805]~~:

8 (1) "Department" means the Department for Community Based Services;

9 (2) "Home county" means the county in which the child's natural parents, adoptive
10 parents, or guardian reside. If the parents are divorced, the home county is the
11 county of residence of the parent with legal custody. If the child is committed, the
12 home county is the county of original commitment or case responsibility;

13 (3) **"Home region"**~~["Home district"]~~ means the Department for Community Based
14 Services **region**~~[district]~~ in which the child's home county is located;

15 (4) "Type of placement" means the living arrangement, including family foster **home,**
16 **child-caring facility,**~~care, private child care,~~ or other residential alternative that is
17 deemed appropriate for a child as determined by the **department**~~[district placement~~
18 ~~coordinator and the social service worker with case responsibility]~~; and

19 (5) "Unmet need" means the type of facility or placement needed to serve the child's
20 needs which is unavailable at the time placement is being sought for the child.

21 ➔Section 7. KRS 199.801 is amended to read as follows:

22 (1) The department shall establish a procedure throughout the state that is designed to
23 determine and expedite the placement of children who are in the custody of **or**
24 **committed to** the department. The procedure shall utilize **state-level and regional**
25 **placement coordinators**~~[a statewide placement coordinator and district placement~~
26 ~~coordinators]~~ who may be state employees or employees of a contracted entity~~, and~~
27 ~~who shall be assigned and located in each of the department's districts].~~

- 1 (2) *The type of placement selected for a child in the custody of or committed to the*
2 *department shall be the best alternative for the child that is in closest proximity to*
3 *the child's home county, including considerations of the child's current early*
4 *care and education provider or school*~~[Upon determining that a child shall be~~
5 ~~removed from the current living arrangement, the social service worker with~~
6 ~~responsibility for the child shall contact the district placement coordinator to~~
7 ~~facilitate the placement. In consultation with the social service worker, the district~~
8 ~~placement coordinator shall determine the appropriate type of placement according~~

- 23 (6) ~~If the type of placement that best suits the child's needs is not available in the~~

- 3 (39) "Motor vehicle offense" means any violation of the nonfelony provisions of KRS
4 Chapters 186, 189, or 189A, KRS 177.300, 304.39-110, or 304.39-117;
- 5 (40) "Near fatality" means an injury that, as certified by a physician, places a child in
6 serious or critical condition;
- 7 (41) "Needs of the child" means necessary food, clothing, health, shelter, and education;
- 8 (42) "Nonoffender" means a child alleged to be dependent, neglected, or abused and who
9 has not been otherwise charged with a status or public offense;
- 10 (43) "Nonsecure facility" means a facility which provides its residents access to the
11 surrounding community and which does not rely primarily on the use of physically
12 restricting construction and hardware to restrict freedom;
- 13 (44) "Nonsecure setting" means a nonsecure facility or a residential home, including a
14 child's own home, where a child may be temporarily placed pending further court
15 action. Children before the court in a county that is served by a state operated secure

11 sixteen (16) years of age or older has committed a motor vehicle offense;
- 12 (52) "Qualified mental health professional" means:
- 13 (a) A physician licensed under the laws of Kentucky to practice medicine or
14 osteopathy, or a medical officer of the government of the United States while
15 engaged in the performance of official duties;
- 16 (b) A psychiatrist licensed under the laws of Kentucky to practice medicine or
17 osteopathy, or a medical officer of the government of the United States while
18 engaged in the practice of official duties, and who is certified or eligible to
19 apply for certification by the American Board of Psychiatry and Neurology,
20 Inc.;
- 21 (c) A psychologist with the health service provider designation, a psychological
22 practitioner, a certified psychologist, or a psychological associate licensed
23 under the provisions of KRS Chapter 319;
- 24 (d) A licensed registered nurse with a master's degree in psychiatric nursing from
25 an accredited institution and two (2) years of clinical experience with mentally
26 ill persons, or a licensed registered nurse with a bachelor's degree in nursing
27 from an accredited institution who is certified as a psychiatric and mental

- 1 health nurse by the American Nurses Association and who has three (3) years
2 of inpatient or outpatient clinical experience in psychiatric nursing and who is
3 currently employed by a hospital or forensic psychiatric facility licensed by
4 the Commonwealth or a psychiatric unit of a general hospital or a regional
5 comprehensive care center;
- 6 (e) A licensed clinical social worker licensed under the provisions of KRS
7 335.100, or a certified social worker licensed under the provisions of KRS
8 335.080 with three (3) years of inpatient or outpatient clinical experience in
9 psychiatric social work and currently employed by a hospital or forensic
10 psychiatric facility licensed by the Commonwealth or a psychiatric unit of a
11 general hospital or a regional comprehensive care center;
- 12 (f) A marriage and family therapist licensed under the provisions of KRS 335.300
13 to 335.399 with three (3) years of inpatient or outpatient clinical experience in
14 psychiatric mental health practice and currently employed by a hospital or
15 forensic psychiatric facility licensed by the Commonwealth, a psychiatric unit
16 of a general hospital, or a regional comprehensive care center; or
- 17 (g) A professional counselor credentialed under the provisions of KRS 335.500 to
18 335.599 with three (3) years of inpatient or outpatient clinical experience in
19 psychiatric mental health practice and currently employed by a hospital or
20 forensic facility licensed by the Commonwealth, a psychiatric unit of a general
21 hospital, or a regional comprehensive care center;
- 22 (53) "Reasonable and prudent parent standard" has the same meaning as in 42 U.S.C.

- 24 (54) "Residential treatment facility" means a facility or group home with more than eight
25 (8) beds designated by the Department of Juvenile Justice or the cabinet for the
26 treatment of children;
- 27 (55) "Retain in custody" means, after a child has been taken into custody, the continued

- 1 holding of the child by a peace officer for a period of time not to exceed twelve (12)
2 hours when authorized by the court or the court-designated worker for the purpose
3 of making preliminary inquiries;
- 4 (56) "Risk and needs assessment" means an actuarial tool scientifically proven to
5 identify specific factors and needs that are related to delinquent and noncriminal

18 in which the parent, guardian, person in a position of authority or special trust, as
19 defined in KRS 532.045, or other person having custodial control or supervision of

21 encourages the use of the child for the purposes of the sexual stimulation of the

21 (71) "Youth alternative center" means a nonsecure facility, approved by the Department
22 of Juvenile Justice, for the detention of juveniles, both prior to adjudication and
23 after adjudication, which meets the criteria specified in KRS 15A.320; and

24 (72) "Youthful offender" means any person regardless of age, transferred to Circuit
25 Court under the provisions of KRS Chapter 635 or 640 and who is subsequently
26 convicted in Circuit Court.

27 ➔Section 14. KRS 605.120 is amended to read as follows:

- 1 (1) The cabinet is authorized to expend available funds to provide for the board,
2 lodging, and care of children who would otherwise be placed in foster care or who
3 are placed by the cabinet in a foster home or boarding home, or may arrange for
4 payments or contributions by any local governmental unit, or public or private
5 agency or organization, willing to make payments or contributions for such purpose.

15 (7) Foster parents shall have the authority, unless the cabinet determines that the
 16 child's religion, race, ethnicity, or national origin prevents it, to make decisions
 17 regarding haircuts and hairstyles for foster children who are in their care for thirty
 18 (30) days or more.

19 ➔Section 15. KRS 610.040 is amended to read as follows:

20 (1) After a public or status offense petition has been filed and after such further
 21 investigation as the court may direct, unless the parties appear voluntarily, the court
 22 shall issue a summons briefly reciting the substance of the petition and requiring the
 23 person who has the custody or control of the child to appear personally and bring
 24 the child before the court at a time and place stated. If the person so summoned is

9 pursuant to this section. This subsection shall also apply in any criminal proceeding
10 in District or Circuit Court regarding a dependent, neglected, or abused child.

11 (4) Upon receipt of a report of an abused, neglected, or dependent child pursuant to this
12 chapter, the cabinet as the designated agency or its delegated representative shall
13 initiate a prompt investigation or assessment of family needs, take necessary action,
14 and shall offer protective services toward safeguarding the welfare of the child. The
15 cabinet shall work toward preventing further dependency, neglect, or abuse of the
16 child or any other child under the same care, and preserve and strengthen family
17 life, where possible, by enhancing parental capacity for adequate child care.

4 care administrators, corrections personnel, or law enforcement agencies,
5 including the county attorney's office, the coroner, and the local child fatality
6 response team, that have a legitimate interest in the case;
- 7 (f) A noncustodial parent when the dependency, neglect, or abuse is
8 substantiated;
- 9 (g) Members of multidisciplinary teams as defined by KRS 620.020 and which
10 operate pursuant to KRS 431.600;
- 11 (h) Employees or designated agents of a children's advocacy center;
- 12 (i) Those persons so authorized by court order; or
- 13 (j) The external child fatality and near fatality review panel established by KRS
14 620.055.
- 15 (6) (a) Files, reports, notes, photographs, records, electronic and other
16 communications, and working papers used or developed by a children's
17 advocacy center in providing services under this chapter are confidential and
18 shall not be disclosed except to the following persons:
- 19 1. Staff employed by the cabinet, law enforcement officers, and
20 Commonwealth's and county attorneys who are directly involved in the
21 investigation or prosecution of the case, including a cabinet
22 investigation or assessment of child abuse, neglect, and dependency in
23 accordance with this chapter;
- 24 2. Medical and mental health professionals listed by name in a release of
25 information signed by the guardian of the child, provided that the
26 information shared is limited to that necessary to promote the physical or
27 psychological health of the child or to treat the child for abuse-related

- 1 symptoms;
- 2 3. The court and those persons so authorized by a court order;~~[-and]~~
- 3 4. The external child fatality and near fatality review panel established by
- 4 KRS 620.055; and
- 5 5. The parties to an administrative hearing conducted by the cabinet or
- 6 its designee in accordance with KRS Chapter 13B in an appeal of a
- 7 cabinet-substantiated finding of abuse or neglect. The children's
- 8 advocacy center may move the Circuit Court in the judicial circuit
- 9 where the hearing is to occur for an in camera review of materials to

- 11 confidential, subject to discovery or protective order in another
- 12 pending civil or criminal matter, or if the release poses a potential
- 13 threat to the safety or well-being of the child. The court may make

10 abuse or neglect has resulted in a child fatality or near fatality.

12 neglect has resulted in a child fatality or near fatality and the cabinet had prior
13 involvement with the child or family. The cabinet shall prepare a summary

4 records about the person making or causing the public disclosure, not already
5 disclosed but related to the information made public, may be disclosed if disclosure
6 is in the best interest of the child or is necessary for the administration of the
7 cabinet's duties under this chapter.

8 (14) As a result of any report of suspected child abuse or neglect, photographs and X-
9 rays or other appropriate medical diagnostic procedures may be taken or caused to
10 be taken, without the consent of the parent or other person exercising custodial
11 control or supervision of the child, as a part of the medical evaluation or
12 investigation of these reports. These photographs and X-rays or results of other
13 medical diagnostic procedures may be introduced into evidence in any subsequent
14 judicial proceedings or an administrative hearing conducted by the cabinet or its
15 designee in accordance with KRS Chapter 13B in an appeal of a cabinet-
16 substantiated finding of child abuse or neglect. The person performing the
17 diagnostic procedures or taking photographs or X-rays shall be immune from
18 criminal or civil liability for having performed the act. Nothing herein shall limit
19 liability for negligence.

20 (15) In accordance with 42 U.S.C. sec. 671, the cabinet shall share information about a
21 child in the custody of the cabinet with a relative or a parent of the child's sibling for
22 the purposes of:

- 23 (a) Evaluating or arranging a placement for the child;
- 24 (b) Arranging appropriate treatment services for the child; or
- 25 (c) Establishing visitation between the child and a relative, including a sibling of
26 the child.

27 ➔Section 20. KRS 620.060 is amended to read as follows:

- 1 (1) The court for the county where the child ordinarily resides or will reside or the
2 county where the child is present may issue an ex parte emergency custody order
3 when it appears to the court that removal is in the best interest of the child and that
4 there are reasonable grounds to believe, as supported by affidavit or by recorded
5 sworn testimony, that one (1) or more of the following conditions exist and that the
6 parents or other person exercising custodial control or supervision are unable or
7 unwilling to protect the child:
- 8 (a) The child is in danger of imminent death or serious physical injury or is being
9 sexually abused;

3 (b) A putative father who registers under this section is responsible for:

12 and an address at which he may be served with notice of the filing of a
13 petition for adoption;

14 (b) The mother's name, date of birth, place of birth, place of residence, and
15 mailing address, if known;

16 (c) The child's name, date of birth, and place of birth, if known;

17 (d) The date that the cabinet receives a putative father's registration;

18 (e) The name of any attorney or agency that requests the cabinet to search the
19 registry pursuant to Section 29 of this Act and the date of the request; and

20 (f) Any other information that the cabinet determines is necessary to access the
21 information in the registry.

22 (6) If a child's mother provides the name of a potential putative father and his place
23 of residence and mailing address, if known, to the cabinet, the cabinet shall, to
24 the best of its ability, notify the potential putative father to inform him of his
25 opportunity to register with the putative father registry.

26 (7) The cabinet shall store the registry's data so that it is accessible under the
27 following:

1 (a) The putative father's name;

2 (b) The mother's name; or

3 (c) The child's name.

4 (8) Subject to subsection (9) of this section, the cabinet shall furnish a certified copy
5 of a putative father's registration form upon written request by:

6 (a) A putative father;

7 (b) A mother;

8 (c) A child;

9 (d) Any party or attorney of record in a pending adoption;

10 (e) An attorney who represents:

11 1. Prospective adoptive parents;

12 2. Petitioners in an adoption;

13 3. A mother;

14 4. A putative father; or

15 5. A child-placing agency;

16 (f) A licensed child-placing agency that represents:

17 1. Prospective adoptive parents;

18 2. Petitioners in an adoption;

19 3. A mother; or

20 4. A putative father; or

21 (g) A court that presides over a pending adoption.

22 (9) The cabinet may release the certified copy of the registration form to a person
23 under subsection (8)(a) to (c) of this section only if the information contained in
24 the registration form names the requesting person.

25 (10) A person who makes a request pursuant to this section shall state that the
26 requesting person is entitled to receive the information under this section. The
27 cabinet may charge a fee of twenty-five dollars (\$25) to a person who makes a

1 request under this section. The fee established by this subsection shall not apply

3 (11) Except as otherwise provided in this section and Section 29 of this Act,
4 information contained within the registry is confidential.

5 (12) The cabinet shall publish information regarding the putative father registry on its

9 (1) An attorney or child-placing agency that arranges a prospective adoption may at
10 any time request that the cabinet search the putative father registry established
11 under Section 28 of this Act to determine whether a putative father is registered
12 in relation to a mother whose child is the subject of the adoption.

13 (2) An attorney or child-placing agency that arranges a prospective adoption may at
14 any time serve the putative father of a child or cause the putative father to be
15 served with actual notice that the mother of the child is considering an adoptive

18 that arranges the adoption shall request that the cabinet search the putative

22 this section, the cabinet shall submit an affidavit to the requesting party verifying

26 the cabinet shall submit a copy of each registration form with its affidavit.

27 (6) A court shall not grant an adoption unless the cabinet's affidavit under this

3 (1) The following persons shall be made parties defendant in an action for leave to
4 adopt a child:

5 (a) The child to be adopted;

6 (b) The biological living parents of a child under eighteen (18), if the child is born
7 in lawful wedlock. If the child is born out of wedlock, its mother; and its
8 father, if one (1) of the following requirements is met:

12 the child, the service of process upon the child shall be had by serving a copy of the
13 summons in the action upon the cabinet, individual, institution or agency, any

26 (f) Emergency medical service, fire department, law enforcement, coroner, and
27 other first responder reports, including but not limited to photos and

1 interviews with family members and witnesses;

4 1. Primary care records, including progress notes; developmental
