

1 AN ACT relating to mining.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 13B.020 is amended to read as follows:

4 (1) The provisions of this chapter shall apply to all administrative hearings conducted
5 by an agency, with the exception of those specifically exempted under this section.
6 The provisions of this chapter shall supersede any other provisions of the Kentucky
7 Revised Statutes and administrative regulations, unless exempted under this section,
8 to the extent these other provisions are duplicative or in conflict. This chapter
9 creates only procedural rights and shall not be construed to confer upon any person
10 a right to hearing not expressly provided by law.

11 (2) The provisions of this chapter shall not apply to:

12 (a) Investigations, hearings to determine probable cause, or any other type of
13 information gathering or fact finding activities;

14 (b) Public hearings required in KRS Chapter 13A for the promulgation of
15 administrative regulations;

16 (c) Any other public hearing conducted by an administrative agency which is
17 nonadjudicatory in nature and the primary purpose of which is to seek public
18 input on public policy making;

19 (d) Military adjudicatory proceedings conducted in accordance with KRS Chapter
20 35;

21 (e) Administrative hearings conducted by the legislative and judicial branches of
22 state government;

23 (f) Administrative hearings conducted by any city, county, urban-county, charter
24 county, or special district contained in KRS Chapters 65 to 109, or any other
25 unit of local government operating strictly in a local jurisdictional capacity;

26 (g) Informal hearings which are part of a multilevel hearing process that affords
27 an administrative hearing at some point in the hearing process if the

- 1 procedures for informal hearings are approved and promulgated in accordance
2 with subsections (4) and (5) of this section;
- 3 (h) Limited exemptions granted for specific hearing provisions and denoted by
4 reference in the text of the applicable statutes or administrative regulations;
- 5 (i) Administrative hearings exempted pursuant to subsection (3) of this section;
- 6 (j) Administrative hearings exempted, in whole or in part, pursuant to
7 subsections (4) and (5) of this section; and
- 8 (k) Any administrative hearing which was commenced but not completed prior to
9 July 15, 1996.

- 26 (4) Any administrative hearing, or portion thereof, may be certified as exempt by the
27 Attorney General based on the following criteria:

- 1 (a) The provisions of this chapter conflict with any provision of federal law or
2 regulation with which the agency must comply, or with any federal law or
3 regulation with which the agency must comply to permit the agency or
4 persons within the Commonwealth to receive federal tax benefits or federal
5 funds or other benefits;
- 6 (b) Conformity with the requirement of this chapter from which exemption is
7 sought would be so unreasonable or so impractical as to deny due process
8 because of undue delay in the conduct of administrative hearings; or
- 9 (c) The hearing procedures represent informal proceedings which are the
10 preliminary stages or the review stages of a multilevel hearing process, if the
11 provisions of this chapter or the provisions of a substantially equivalent
12 hearing procedure exempted under subsection (3) of this section are applied at
13 some level within the multilevel process.
- 14 (5) The Attorney General shall not exempt an agency from any requirement of this
15 chapter until the agency establishes alternative procedures by administrative
16 regulation which, insofar as practical, shall be consistent with the intent and purpose
17 of this chapter. When regulations for alternative procedures are submitted to the
18 Administrative Regulation Review Subcommittee, they shall be accompanied by the
19 request for exemption and the approval of exemption from the Attorney General.
20 The decision of the Attorney General, whether affirmative or negative, shall be
21 subject to judicial review in the Franklin Circuit Court within thirty (30) days of the
22 date of issuance. The court shall not overturn a decision of the Attorney General
23 unless the decision was arbitrary or capricious or contrary to law.
- 24 (6) Except to the extent precluded by another provision of law, a person may waive any
25 procedural right conferred upon that person by this chapter.
- 26 ➔Section 2. KRS 350.0301 is amended to read as follows:
- 27 (1) Any person who considers himself *or herself* aggrieved by any determination made

1 by the cabinet under this chapter may file, in accordance with administrative
2 regulations promulgated by the cabinet under the provisions of this chapter, a
3 petition alleging that the determination is contrary to law or fact and is injurious to
4 him, the grounds and reasons therefor, and demand a hearing. Unless the cabinet
5 considers that the petition is frivolous, it shall serve written notice of the petition on
6 each person named therein and shall schedule a hearing before the cabinet not less
7 than twenty-one (21) days after the date of the notice unless the person complained
8 against waives in writing the twenty-one (21) day period. The right to demand a
9 hearing pursuant to this section shall be limited to a period of thirty (30) days after
10 the petitioner has had actual notice of the determination complained of, or could
11 reasonably have had notice. However, the petitioner shall have the opportunity to
12 contest the validity of an underlying notice of noncompliance in a timely-filed
13 demand for hearing to contest the validity of a cessation order issued for a failure to
14 abate the violation contained in the notice of noncompliance.

15 (2) All hearings, other than conferences, under this chapter shall be held before a
16 hearing officer, duly qualified to practice law in the Commonwealth of Kentucky,
17 who may be a full-time employee of the cabinet, serve by contract, or be paid on a
18 per diem basis in the discretion of the cabinet. After the conclusion of the hearing,
19 the hearing officer shall within thirty (30) days make to the secretary a report and
20 recommended order which shall contain a finding of fact and a conclusion of law. If
21 the secretary finds upon written request of the hearing officer that additional time is
22 needed, the secretary may grant an extension. The hearing officer shall serve a copy
23 of his report and recommended order upon all parties of record and their attorney of
24 record to the proceeding, and they shall be granted the right to file exceptions
25 thereto within fourteen (14) days of service. Any party may submit a written
26 response to exceptions within twenty-one (21) days of service of the report and
27 recommended order. Exceptions and responses not timely filed shall be noted and

1 made a part of the record but shall not be considered by the secretary in making a
2 final order. The secretary shall consider the report, exceptions, and recommended
3 order and decide the case. The decision shall be served by mail upon all parties and
4 their attorney of record and shall be a final order of the cabinet.

5 (3) Any party to a hearing under this subsection may be represented by counsel, may
6 make oral or written argument, offer testimony, cross-examine witnesses, or take
7 any combination of these actions. The record of the hearing shall be open to public
8 inspection, and copies thereof shall be made available to any person upon payment
9 of the actual cost of reproducing the original.

10 (4) All hearings conducted pursuant to this chapter shall be open to the public.

11 (5) The cabinet shall promulgate administrative regulations, pursuant to the provisions
12 set forth in this chapter, establishing formal and informal hearing procedures by
13 which any hearing shall, upon the written request of the operator, permittee, or
14 person, be held in the county or regional office where the surface coal mining
15 operation is located, before an impartial hearing officer who is independent of any
16 prosecutorial functions of the cabinet. The administrative regulations shall provide
17 for the conduct of hearings and investigation of any matter relating to the regulation
18 of surface coal mining and reclamation operations and provide for the assessment
19 and payment of civil penalties, ~~including the placement of proposed civil penalty~~
20 ~~assessments into an escrow account prior to a formal hearing on the amount of the~~
21 ~~assessment; and provide for a waiver of the placement of the proposed civil~~
22 ~~penalties into escrow for those individuals who demonstrate with substantial~~
23 ~~evidence an inability to pay the proposed civil penalties into escrow}. The~~
24 procedures developed pursuant to this subsection shall provide that the hearings be
25 held in the most expeditious manner possible within the time constraints established
26 under this chapter. No person who presided at a prior hearing shall either preside at
27 a subsequent hearing or participate in any further decision or subsequent

1 administrative appeal in the same matter.

2 (6) The cabinet may promulgate administrative regulations pursuant to the provisions
3 set forth in this chapter establishing procedures for the holding of administrative
4 conferences needed to implement the provisions of this chapter.

5 (7) The secretary may designate a deputy to sign any or all final orders of the cabinet,
6 whether the orders are the result of hearing or agreement.

7 ➔Section 3. KRS 350.064 is amended to read as follows:

8 (1) After a surface coal mining and reclamation permit application has been approved
9 but before the permit is issued, the applicant shall file with the regulatory authority,
10 on a form prescribed and furnished by the regulatory authority, a reclamation bond
11 for performance payable, as appropriate, to the state, and conditional upon faithful
12 performance of all the requirements of this chapter and the permit. The reclamation
13 bond shall cover that area of land within the permit area upon which the applicant
14 will initiate and conduct surface coal mining and reclamation operations within the
15 initial term of the permit. As succeeding increments of surface coal mining and
16 reclamation operations are to be initiated and conducted within the permit area, the
17 permittee shall file with the cabinet an additional bond or bonds to cover the
18 increments in accordance with this section.

19 (2) ~~[(The cabinet may accept the reclamation bond of the applicant itself without~~
20 ~~separate surety when the applicant demonstrates to the satisfaction of the cabinet the~~
21 ~~existence of a suitable agent to receive service of process and a history of financial~~
22 ~~solveney and continuous operation sufficient for authorization to self-insure or bond~~
23 ~~the amount or in lieu of the establishment of a bonding program, as set forth in this~~
24 ~~section;]~~The cabinet may approve an alternative system that will achieve the
25 objectives and purposes of the bonding program pursuant to this section.

26 ➔Section 4. KRS 350.070 is amended to read as follows:

27 (1) Any extensions of the area covered by the permit, except incidental boundary

1 revisions, shall be made by application for another permit or an amendment to the
2 permit. [~~However, extensions of the underground mining area that are not incidental
3 boundary revisions and do not include planned subsidence or other new proposed
4 surface disturbances may be made by application for a major revision to the permit.~~]

5 (2) For an amendment, the permittee shall file an application, map, and revised
6 reclamation plan in the same form and with the same content as required for an
7 original application under this chapter. He *or she* shall pay a basic fee set by
8 regulation and bearing a reasonable relationship to the cost of processing the permit
9 application, not to exceed one thousand seven hundred fifty dollars (\$1,750), plus a
10 fee set by regulation, not to exceed seventy-five dollars (\$75), for each acre or
11 fraction of an acre for the increase requested. He *or she* shall file with the cabinet a
12 supplemental bond in the amount to be determined under the provisions of KRS
13 350.060(11) for each acre or fraction of an acre of the increase approved. This
14 application shall be subject to all of the same requirements as an original
15 application, including, but not limited to, the same public notice, review, and
16 issuance or denial provisions.

17 (3) If the cabinet approves a reduction in the acreage covered by the permit, it shall
18 release the bond for each acre reduced, but the bond shall not be reduced below ten
19 thousand dollars (\$10,000). If the cabinet approves a reduction in acreage, it shall
20 transfer the acreage fee for each acre reduced to acreage fees for subsequent permit
21 applications by the permittee.

22 (4) The cabinet shall promulgate regulations specifying the permit application
23 information requirements and procedures, including notice and hearing, which shall
24 apply depending on the scale or extent of a permit revision. Any revision which
25 proposes significant alterations in the reclamation plan shall be subject to the notice
26 and hearing requirements as set forth in the regulations of the cabinet. The applicant
27 for a revision shall pay a basic fee set by regulation, not to exceed seven hundred

1 fifty dollars (\$750) for a minor revision and one thousand seven hundred fifty
2 dollars (\$1,750) for a major revision, plus a fee set by regulation not to exceed
3 seventy-five dollars (\$75), for each acre or fraction of an acre included in an
4 incidental boundary revision.

- 5 (5) Incidental boundary revisions shall be deemed minor revisions if they:
- 6 (a) Do not exceed ten percent (10%) of the initial permit acreage;
 - 7 (b) Are contiguous with the permit acreage;
 - 8 (c) Are within the same watershed as the initial permit acreage;
 - 9 (d) Are required for an orderly continuation of the mining operation;
 - 10 (e) Cover the same coal seam or seams as in the permit;
 - 11 (f) Would only involve lands for which the hydrologic and geologic data and the
12 probable hydrologic consequences analysis contained in the permit are
13 applicable to the proposed incidental boundary revision;
 - 14 (g) Would not involve properties designated as unsuitable for mining, or any
15 properties eligible for listing on the National Register of Historic Places;
 - 16 (h) Would not involve any of the special categories of mining listed in 30 C.F.R.
17 Part 785 including, but not limited to, prime farmland and coal preparation
18 plants, unless the approved permit already includes the relevant category;
 - 19 (i) Would not constitute a change in the method of mining; and
 - 20 (j) Would be reclaimed in conformity with the initial reclamation plan.
- 21 (6) For the purpose of this section, the maximum acreage allowed to be added by an
22 incidental boundary revision shall be as follows:
- 23 (a) Surface operations shall be allowed up to twenty (20) acres;
 - 24 (b) ~~Underground operations shall be allowed up to ten percent (10%) of the~~
25 ~~original permitted acreage of the underground workings or twenty (20) acres,~~
26 ~~whichever is less;~~
 - 27 (c) Surface disturbances of underground mines including, but not limited to, face-

1 up areas and haul roads, shall be allowed up to twenty (20) acres; **and**
 2 ~~(c)~~~~(d)~~ The cumulative acreage added by successive revisions shall not exceed
 3 the above limitations.

4 ➔SECTION 5. A NEW SECTION OF KRS 350.240 TO 350.280 IS CREATED
 5 TO READ AS FOLLOWS:

6 **A person shall not conduct mining for limestone, dolomite, sand, gravel, clay,**
 7 **fluorspar, or other vein minerals without first obtaining a permit from the cabinet.**
 8 **However, no permit shall be required for the excavation of limestone, dolomite, sand,**
 9 **gravel, clay, fluorspar, or other vein minerals by a landowner for personal,**
 10 **noncommercial use if:**

11 **(1) Fifty (50) tons or less are excavated in twelve (12) successive calendar months;**

12 **(2) They are excavated from land owned by the landowner; and**

13 **(3) They are used only on the property owned by the landowner, as provided in**
 14 **Article II(a) of Section 6 of this Act.**

15 ➔Section 6. KRS 350.300 is amended to read as follows:

16 The Interstate Mining Compact is hereby enacted into law and entered into with all other
 17 jurisdictions legally joining therein in the form substantially as follows:

18 ARTICLE I

19 Findings and Purposes

20 (a) The party States find that:

21 1. Mining and the contributions thereof to the economy and well-being of every
 22 State are of basic significance.

23 2. The effects of mining on the availability of land, water and other resources for
 24 other uses present special problems which properly can be approached only with due
 25 consideration for the rights and interests of those engaged in mining, those using or
 26 proposing to use these resources for other purposes, and the public.

27 3. Measures for the reduction of the adverse effects of mining on land, water and

1 other resources may be costly and the devising of means to deal with them are of both
2 public and private concern.

3 4. Such variables as soil structure and composition, physiography, climatic
4 conditions, and the needs of the public make impracticable the application to all mining
5 areas of a single standard for the conservation, adaptation, or restoration of mined land, or
6 the development of mineral and other natural resources; but justifiable requirements of
7 law and practice relating to the effects of mining on land, water, and other resources may
8 be reduced in equity or effectiveness unless they pertain similarly from state to state for
9 all mining operations similarly situated.

10 5. The States are in a position and have the responsibility to assure that mining
11 shall be conducted in accordance with sound conservation principles, and with due regard
12 for local conditions.

13 (b) The purposes of this compact are to:

14 1. Advance the protection and restoration of land, water and other resources
15 affected by mining.

16 2. Assist in the reduction or elimination or counteracting of pollution or
17 deterioration of land, water and air attributable to mining.

18 3. Encourage, with due recognition of relevant regional, physical, and other
19 differences, programs in each of the party States which will achieve comparable results in
20 protecting, conserving, and improving the usefulness of natural resources, to the end that
21 the most desirable conduct of mining and related operations may be universally
22 facilitated.

23 4. Assist the party States in their efforts to facilitate the use of land and other
24 resources affected by mining, so that such use may be consistent with sound land use,
25 public health, and public safety, and to this end to study and recommend, wherever
26 desirable, techniques for the improvement, restoration or protection of such land and
27 other resources.

1 5. Assist in achieving and maintaining an efficient and productive mining
2 industry and in increasing economic and other benefits attributable to mining.

3 ARTICLE II

4 Definitions

5 As used in this compact, the term:

6 (a) "Mining" means the breaking of the surface soil in order to facilitate or
7 accomplish the extraction or removal of minerals, ores, or other solid matter; any activity
8 or process constituting all or part of a process for the extraction or removal of minerals,
9 ores, and other solid matter from its original location; and the preparation, washing,
10 cleaning, or other treatment of minerals, ores, or other solid matter so as to make them
11 suitable for commercial, industrial, or construction use; but shall not include those
12 aspects of deep mining not having significant effect on the surface, and shall not include
13 excavation or grading when conducted solely in aid of ~~on-site~~ farming or construction
14 pursuant to Section 5 of this Act.

15 (b) "State" means a State of the United States, the District of Columbia, the
16 Commonwealth of Puerto Rico, or a Territory or Possession of the United States.

17 ARTICLE III

18 State Programs

19 Each party State agrees that within a reasonable time it will formulate and establish
20 an effective program for the conservation and use of mined land, by the establishment of
21 standards, enactment of laws, or the continuing of the same in force, to accomplish:

22 1. The protection of the public and the protection of adjoining and other
23 landowners from damage to their lands and the structures and other property thereon
24 resulting from the conduct of mining operations or the abandonment or neglect of land
25 and property formerly used in the conduct of such operations.

26 2. The conduct of mining and the handling of refuse and other mining wastes in
27 ways that will reduce adverse effects on the economic, residential, recreational or

1 aesthetic value and utility of land and water.

2 3. The institution and maintenance of suitable programs for adaptation,
3 restoration, and rehabilitation of mined lands.

4 4. The prevention, abatement and control of water, air and soil pollution
5 resulting from mining, present, past and future.

6 ARTICLE IV

7 Powers

8 In addition to any other powers conferred upon the Interstate Mining Commission,
9 established by Article V of this compact, such Commission shall have power to:

10 1. Study mining operations, processes and techniques for the purpose of gaining
11 knowledge concerning the effects of such operations, processes and techniques on land,
12 soil, water, air, plant and animal life, recreation, and patterns of community or regional
13 development or change.

14 2. Study the conservation, adaptation, improvement and restoration of land and
15 related resources affected by mining.

16 3. Make recommendations concerning any aspect or aspects of law or practice
17 and governmental administration dealing with matters within the purview of this
18 compact.

19 4. Gather and disseminate information relating to any of the matters within the
20 purview of this compact.

21 5. Cooperate with the federal government and any public or private entities
22 having interests in any subject coming within the purview of this compact.

23 6. Consult, upon the request of a party State and within resources available
24 therefor, with the officials of such State in respect to any problem within the purview of
25 this compact.

26 7. Study and make recommendations with respect to any practice, process,
27 technique, or course of action that may improve the efficiency of mining or the economic

1 yield from mining operations.

2 8. Study and make recommendations relating to the safeguarding of access to
3 resources which are or may become the subject of mining operations to the end that the
4 needs of the economy for the products of mining may not be adversely affected by
5 unplanned or inappropriate use of land and other resources containing minerals or
6 otherwise connected with actual or potential mining sites.

7 ARTICLE V

8 The Commission

9 (a) There is hereby created an agency of the party States to be known as the
10 "Interstate Mining Commission," hereinafter called "the Commission." The Commission
11 shall be composed of one commissioner from each party State who shall be the Governor
12 thereof. Pursuant to the laws of his party State, each Governor shall have the assistance of
13 an advisory body (including membership from mining industries, conservation interests,
14 and such other public and private interests as may be appropriate) in considering
15 problems relating to mining and in discharging his responsibilities as the commissioner of
16 his State on the Commission. In any instance where a Governor is unable to attend a
17 meeting of the Commission or perform any other function in connection with the business
18 of the Commission, he shall designate an alternate, from among the members of the
19 advisory body required by this paragraph, who shall represent him and act in his place and
20 stead. The designation of an alternate shall be communicated by the Governor to the
21 Commission in such manner as its bylaws may provide.

22 (b) The commissioners shall be entitled to one vote each on the Commission. No
23 action of the Commission making a recommendation pursuant to Article IV-3, IV-7, and
24 IV-8 or requesting, accepting or disposing of funds, services, or other property pursuant
25 to this paragraph, Articles V(g), V(h), or VII shall be valid unless taken at a meeting at
26 which a majority of the total number of votes on the Commission is cast in favor thereof.
27 All other action shall be by a majority of those present and voting; provided that action of

1 the Commission shall be only at a meeting at which a majority of the commissioners, or
2 their alternates, is present. The Commission may establish and maintain such facilities as
3 may be necessary for the transacting of its business. The Commission may acquire, hold,
4 and convey real and personal property and any interest therein.

5 (c) The Commission shall have a seal.

6 (d) The Commission shall elect annually, from among its members, a chairman, a
7 vice chairman, and a treasurer. The Commission shall appoint an Executive Director and
8 fix his duties and compensation. Such Executive Director shall serve at the pleasure of
9 the Commission. The Executive Director, the Treasurer, and such other personnel as the
10 Commission shall designate shall be bonded. The amount or amounts of such bond or
11 bonds shall be determined by the Commission.

12 (e) Irrespective of the civil service, personnel or other merit system laws of any of
13 the party States, the Executive Director with the approval of the Commission, shall
14 appoint, remove or discharge such personnel as may be necessary for the performance of
15 the Commission's functions, and shall fix the duties and compensation of such personnel.

16 (f) The Commission may establish and maintain independently or in conjunction
17 with a party State, a suitable retirement system for its employees. Employees of the
18 Commission shall be eligible for social security coverage in respect of old age and
19 survivor's insurance provided that the Commission takes such steps as may be necessary
20 pursuant to the laws of the United States, to participate in such program of insurance as a
21 governmental agency or unit. The Commission may establish and maintain or participate
22 in such additional programs of employee benefits as it may deem appropriate.

23 (g) The Commission may borrow, accept or contract for the services of personnel
24 from any State, the United States, or any other governmental agency, or from any person,
25 firm, association or corporation.

26 (h) The Commission may accept for any of its purposes and functions under this
27 compact any and all donations, and grants of money, equipment, supplies, materials and

1 services, conditional or otherwise, from any State, the United States, or any other
2 governmental agency, or from any person, firm, association or corporation, and may
3 receive, utilize and dispose of the same. Any donation or grant accepted by the
4 Commission pursuant to this paragraph or services borrowed pursuant to paragraph (g) of
5 this Article shall be reported in the annual report of the Commission. Such report shall
6 include the nature, amount and conditions, if any, of the donation, grant or services
7 borrowed and the identity of the donor or lender.

8 (i) The Commission shall adopt bylaws for the conduct of its business and shall
9 have the power to amend and rescind these bylaws. The Commission shall publish its
10 bylaws in convenient form and shall file a copy thereof and a copy of any amendment
11 thereto, with the appropriate agency or officer in each of the party States.

12 (j) The Commission annually shall make to the Governor, legislature and
13 advisory body required by Article V(a) of each party State a report covering the activities
14 of the Commission for the preceding year, and embodying such recommendations as may
15 have been made by the Commission. The Commission may make such additional reports
16 as it may deem desirable.

17 ARTICLE VI

18 Advisory, Technical, and Regional Committees

19 The Commission shall establish such advisory, technical, and regional committees
20 as it may deem necessary, membership on which shall include private persons and public
21 officials, and shall cooperate with and use the services of any such committees and the
22 organizations which the members represent in furthering any of its activities. Such
23 committees may be formed to consider problems of special interest to any party States,
24 problems dealing with particular commodities or types of mining operations, problems
25 related to reclamation, development, or use of mine land, or any other matters of concern
26 to the Commission.

27 ARTICLE VII

1 Finance

2 (a) The Commission shall submit to the Governor or designated officer or officers
3 of each party State a budget of its estimated expenditures for such period as may be
4 required by the laws of that party State for presentation to the legislature thereof.

5 (b) Each of the Commission's budgets of estimated expenditures shall contain
6 specific recommendations of the amount or amounts to be appropriated by each of the
7 party States. The total amount of appropriations requested under any such budget shall be
8 apportioned among the party States as follows: one-half in equal shares; and the
9 remainder in proportion to the value of minerals, ores, and other solid matter mined. In
10 determining such values, the Commission shall employ such available public source or
11 sources of information as, in its judgment, present the most equitable and accurate
12 comparisons among the party States. Each of the Commission's budgets of estimated
13 expenditures and requests for appropriations shall indicate the source or sources used in
14 obtaining information concerning value of minerals, ores, and other solid matter mined.

15 (c) The Commission shall not pledge the credit of any party State. The
16 Commission may meet any of its obligations in whole or in part with funds available to it
17 under Article V(h) of this compact: provided that the Commission takes specific action
18 setting aside such funds prior to incurring any obligation to be met in whole or in part in
19 such manner. Except where the Commission makes use of funds available to it under
20 Article V(h) hereof, the Commission shall not incur any obligation prior to the allotment
21 of funds by the party States adequate to meet the same.

22 (d) The Commission shall keep accurate accounts of all receipts and
23 disbursements. The receipts and disbursements of the Commission shall be subject to the
24 audit and accounting procedures established under its bylaws. All receipts and
25 disbursements of funds handled by the Commission shall be audited yearly by a qualified
26 public accountant and the report of the audit shall be included in and become part of the
27 annual report of the Commission.

1 (e) The accounts of the Commission shall be open at any reasonable time for
2 inspection by duly constituted officers of the party States and by any persons authorized
3 by the Commission.

4 (f) Nothing contained herein shall be construed to prevent Commission
5 compliance with laws relating to audit or inspection of accounts by or on behalf of any
6 government contributing to the support of the Commission.

7 ARTICLE VIII

8 Entry into Force and Withdrawal

9 (a) This compact shall enter into force when enacted into law by any four or more
10 States. Thereafter, this compact shall become effective as to any other State upon its
11 enactment thereof.

12 (b) Any party State may withdraw from this compact by enacting a statute
13 repealing the same, but no such withdrawal shall take effect until one year after the
14 Governor of the withdrawing State has given notice in writing of the withdrawal to the
15 Governors of all other party States. No withdrawal shall affect any liability already
16 incurred by or chargeable to a party State prior to the time of such withdrawal.

17 ARTICLE IX

18 Effect on Other Laws

19 Nothing in this compact shall be construed to limit, repeal or supersede any other
20 law of any party State.

21 ARTICLE X

22 Construction and Severability

23 This compact shall be liberally construed so as to effectuate the purposes thereof.
24 The provisions of this compact shall be severable and if any phrase, clause, sentence or
25 provision of this compact is declared to be contrary to the constitution of any State or of
26 the United States or the applicability thereof to any government, agency, person or
27 circumstance is held invalid, the validity of the remainder of this compact and the

1 applicability thereof to any government, agency, person or circumstance shall not be
2 affected thereby. If this compact shall be held contrary to the constitution of any State
3 participating herein, the compact shall remain in full force and effect as to the remaining
4 party States and in full force and effect as to the State affected as to all severable matters.

5 ➔Section 7. KRS 350.518 is amended to read as follows:

- 6 (1) In addition to the provisions of KRS 350.500 to 350.521, each permittee shall
7 submit a permit-specific bond in accordance with KRS 350.060(11) and all
8 administrative regulations promulgated thereunder.
- 9 (2) Each permittee subject to KRS 350.515(1) shall pay to the fund a fee for each ton of
10 coal mined and sold by surface and underground coal mining operations from each
11 permit area. For the purposes of assessing tonnage fees, all permits subject to
12 eligibility for expenditures from the fund shall be assigned to one (1) of the
13 following classifications:

- 25 2. Pay the tonnage fees set forth in paragraphs (a) and (b) of this subsection
26 to the fund in lieu of tonnage fees otherwise due under KRS 350.725(2);
27 and

1 3. Continue to receive subsidization of the reclamation bonding authorized
2 under KRS 350.500 to 350.521 and the administrative regulations
3 adopted pursuant thereto.

4 The fund shall continue to provide coverage for existing bonds previously
5 issued for them by the voluntary bond pool;

6 (e) Permits which are used exclusively for coal preparation and processing
7 operations, loading activities, disposal of refuse operations, coal haulage and
8 access roads, mine maintenance areas, and other support facilities, and other
9 permits not subject to the provisions of paragraphs (a) and (b) of this
10 subsection as determined by the commission, shall pay an annual fee of ten
11 dollars (\$10) per acre to the fund in equal quarterly installments; and

12 (f) Any permits, or expired permits, not subject to the fees in paragraphs (a) to (e)
13 of this subsection shall pay an annual fee of six dollars (\$6) per surface acre to

17 manner and have reached final disposition, except the commission may
18 for good cause shown and by unanimous vote exclude violations that
19 have been terminated by the cabinet with no civil penalty;
- 20 7. Not committed more than eight (8) violations of surface mining
21 permanent program requirements set forth in this chapter or any
22 performance standards for mining established in administrative
23 regulations promulgated by the cabinet pursuant to this chapter and
24 which have reached final disposition on any one (1) permit in any twelve
25 (12) month period of the most recent thirty-six (36) months of operation,
26 except the commission may for good cause shown and by unanimous
27 vote exclude the twelve (12) month period on one (1) permit during

- 1 which the largest number of violations occurred and may for good cause
2 shown and by unanimous vote exclude violations that were timely
3 abated and terminated by the cabinet with no civil penalty; or
- 4 8. Not had civil penalties under this chapter or imposed pursuant to

1 ➔Section 8. KRS 350.990 is amended to read as follows:

2 (1) Any permittee, person, or operator who violates any of the provisions of this chapter
3 or administrative regulations promulgated pursuant thereto or who fails to perform
4 the duties imposed by these provisions, except the refusal or failure to obtain a
5 permit or other authorization as provided in this chapter, or who violates any
6 determination or order issued pursuant to the provisions of this chapter, may be
7 liable to a civil penalty of not more than five thousand dollars (\$5,000) for the
8 violation, and an additional civil penalty of not more than five thousand dollars
9 (\$5,000) for each day during which the violation continues, and in addition, may be
10 enjoined from continuing the violations provided in this section. Any permittee,
11 operator, or person who fails to abate a violation noted in a notice of noncompliance
12 or an order for immediate compliance and cessation within the time period
13 prescribed for the abatement shall be assessed a civil penalty of not less than seven

24 required by the cabinet pursuant to KRS 350.057 or administrative regulations
25 promulgated pursuant thereto, or any person or operator who engages in other
26 mining operations, without proper authorization as required by this chapter or
27 administrative regulations promulgated pursuant thereto, shall be liable to a civil

1 penalty for damages to the Commonwealth of not less than five thousand dollars
2 (\$5,000) nor more than twenty-five thousand dollars (\$25,000) and in addition, may

7 administrative regulations promulgated pursuant thereto, with the intent to
8 violate the laws, shall be guilty of a Class D felony.

9 (b) Any person or operator who in violation of KRS 350.060(1)(b) willfully and
10 knowingly receives, transports, sells, conveys, transfers, trades, exchanges,
11 donates, purchases, delivers, or in any way derives benefit from coal removed
12 from any surface mining operations conducted in violation of KRS
13 350.060(1)(a) or 350.057 shall be guilty of a Class D felony.

14 (6) Any person who violates any of the provisions of KRS 350.600 or administrative
15 regulations promulgated pursuant thereto shall be subject to civil penalties of not
16 more than twenty-five thousand dollars (\$25,000). Each day of continuing violation
17 shall be deemed a separate violation.

18 (7) Any permittee, operator, or person who knowingly makes any false statement,
19 representation, or certification, or knowingly fails to make any statement,
20 representation, or certification in any application, record, report, plan, or other
21 document filed or required to be maintained by the cabinet, shall upon conviction be
22 guilty of a Class A misdemeanor.

23 (8) Except as permitted by law, any permittee, operator, or person who willfully and
24 knowingly resists, prevents, impedes, or interferes with the secretary or other
25 personnel of the cabinet in the performance of duties pursuant to this chapter shall
26 be guilty of a Class A misdemeanor.

27 (9) When a corporate permittee violates any provision of this chapter or administrative

1 regulation promulgated pursuant thereto or fails or refuses to comply with any final
2 order issued by the secretary, any director, officer, or agent of the corporation who
3 willfully and knowingly authorized, ordered, or carried out the violation, failure, or
4 refusal shall be subject to the same civil penalties, fines, and imprisonment as may
5 be imposed upon a person pursuant to this section.

6 (10) Upon notice by the secretary that any surety has failed to comply with the
7 provisions of KRS 350.032(3), the commissioner of the Kentucky Department of
8 Insurance shall revoke the surety's certificate of authority to conduct insurance

10 (11) The cabinet, upon written request by any permittee, person, or operator subject to
11 any penalty assessment under this section and pursuant to procedures, if any, set
12 forth by administrative regulation and after consultation with the local county fiscal
13 court, may allow as an alternative to the payment of any assessed penalty under this
14 section the performance of in-kind reclamation, environmental rehabilitation, or
15 similar action to correct environmental pollution. The in-kind work shall not
16 substitute for those remedial measures mandated by the cabinet for the correction of

23 rehabilitation work, including direct equipment, personnel, and material cost, but
24 excluding administrative overhead or transportation costs. Failure to perform the in-
25 kind work as agreed upon by the person or operator subject to the penalty
26 assessment shall reinstate the liability of the person, permittee, or operator for the
27 full amount of the assessed penalty. The cabinet may prepare and promulgate

1 administrative regulations as are necessary to implement and administer the
2 provisions of this subsection.

3 ➔Section 9. KRS 351.090 is amended to read as follows:

4 (1) The Governor shall appoint an adequate number of mine safety specialists to ensure
5 at least two (2) inspections annually at all surface mines, provided the mine is in
6 operation the entire year or the proportionate thereof, of all mines in the
7 Commonwealth and sufficient additional mine safety specialists to enable the
8 commissioner to provide adequate monitoring of coal mines where conditions or
9 management policy dictate that more inspections are needed to ensure the safety of
10 miners. Underground mines shall be inspected at least six (6) times annually; except
11 that the commissioner shall have the discretion to require up to three (3) of the six
12 (6) required mine safety inspections to be mine safety analysis visits pursuant to
13 KRS 351.242. At least one (1) inspection shall be a full electrical inspection. One

15 Governor shall also appoint an adequate number of mine safety specialists to
16 perform safety analysis and safety instruction. The term of office of each mine
17 safety specialist shall be during the period of capable, efficient service and good
18 behavior.

19 (2) All mine safety specialists shall have a thorough knowledge of first aid and mine
20 rescue and be able to instruct in first aid and mine rescue~~[, and shall possess~~
21 ~~thoroughly the knowledge required of the commissioner by KRS 351.060,]~~ and
22 shall have a thorough and practical knowledge of mining gained by at least five (5)
23 years' experience in coal mines in the Commonwealth. For the purposes of this
24 subsection, a degree in mining engineering from a recognized institution shall be
25 deemed equivalent to two (2) years of practical experience in coal mines or an
26 associate degree in mining technology from a recognized institution shall be
27 deemed equivalent to one (1) year practical experience in coal mines. A person

1 desiring to use a mining engineering or technology degree for practical experience
2 credit shall file proof of having received a degree prior to examination.

3 (3) No person shall be appointed to the office of mine safety specialist unless he or she
4 holds a current mine foreman's certificate. A person appointed as mine safety
5 specialist shall pass an examination administered by the department. The
6 commissioner may recommend to the Governor applicants for the positions of mine
7 safety specialist who have successfully passed the examination and are proved by
8 worth, training, and experience to be the most competent of the applicants.

9 (4) Mine safety specialists shall be of good moral character and temperate habits and
10 shall not, while holding office, act in any official capacity in operating any coal
11 mine.

12 (5) No reimbursement for traveling expenses shall be made except on an itemized
13 accounting for the expenses submitted by mine safety specialists who shall verify
14 upon oath that the expenses were incurred in the discharge of their official duties.

15 (6) Each mine safety specialist shall take oath, which shall be certified by the officer
16 administering it. The oath, in writing, and the certificate, shall be filed in the office
17 of the Secretary of State.

18 (7) Each mine inspector, mine safety analyst, electrical inspector, and mine safety
19 instructor shall give bond with surety approved by the Governor.

20 (8) Each mine safety specialist shall provide authorization to the division to perform a
21 criminal background check by means of a fingerprint check by the Department of
22 Kentucky State Police. The results of the state criminal background check shall be
23 sent to the director of the division. Any fee charged by the Department of Kentucky
24 State Police shall be an amount no greater than the actual cost of processing the
25 request and conducting the search.
